## ***Release of Liability-Members***

In consideration of being permitted to participate in any activities conducted by the Choo Choo Shag Club, releasor for themselves, releasor's spouse, legal representatives, heirs and assigns, hereby releases, waives and discharges the Choo Choo Shag Club, its officers, board members, and members (herein referred to as "releasee") and each of them from all liability to releasor, releasor's spouse, legal representatives, heirs and assigns, for any and all loss or damage. As well as any claim or damages resulting therefrom, on account of injury to releasor's person or property. Even injury resulting in death of the releasor, whether caused by the negligence of releasees or otherwise, while the releasor is for any purpose participating in any activity or function sponsored by the Choo Choo Shag Club in 2024-2025. This includes all events and activities during pandemics or other similar situations. In addition, it shall be the responsibility of the releasor to decide if Club requirements, governmental authority requirements, or other involved entity requirements will provide the protections expected by the releasor to participate and if not, the releasor shall reconsider participation and do so at their own risk.
